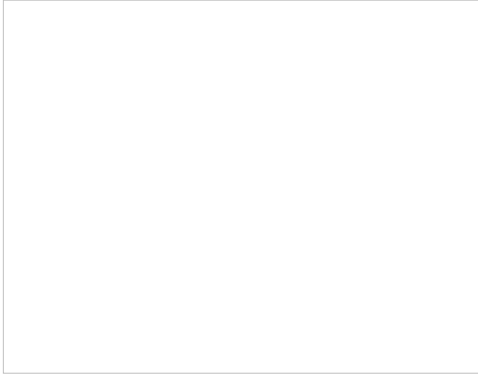


Inbound Passengers



Welcome to Türkiye. We wish you enjoy your stay in our country. In this video, we will give you brief information about the items you can bring with you upon your arrival in Türkiye. All goods, vehicles and persons entering and leaving Türkiye can be inspected and searched by the Customs Office. Type, quantity and value limits of the goods that you can bring with you when entering Türkiye as a passenger are determined in the Customs Legislation. Some of the items that you can buy from the stores located at the border gates, seaports and airports where you enter Türkiye or bring with you are exempt from customs duties. You can bring products such as watches, tablets, cameras, etc. that you have used during your trip

and alcoholic, tobacco, cosmetics, medications, mobile phones and food products within certain limits.

The limits for tobacco products are;

600 cigarettes

100 cigarillos, not heavier than 3 grams each

50 cigars

250 grams of shredded tobacco with 200 cigarette sheets

and 250 grams of pipe tobacco.

This exemption is not applied to the passengers who are under 18 years of age.

The limits for alcoholic products are;

1 liter for alcohol and alcoholic beverages exceeding 22% alcohol,

2 liters for alcohol and alcoholic beverages not exceeding 22% alcohol

This exemption is not applied to the passengers who are under 18 years of age.

Medication - With a medical report or prescription, you can bring a reasonable amount of medication you need for your personal treatment.

Food - You have the right to bring 1 kilogram each of tea, coffee, chocolate and sugar products.

Passengers are not allowed to bring meat and dairy products.

Cosmetics - Without exceeding 600 ml in quantity, you can bring cologne, perfume, lavender, essence or lotion and 5 skin care and make-up products.

Mobile Phone - You can bring one mobile phone in every 3 years. You can use this phone only by a telephone line that is registered upon your personal ID number. This exemption is applied regardless of the value of the mobile phone. However, the IMEI registration of the device must be made within 120 days.

Other Goods

If there is no limit is set for the goods that you bring along to Türkiye, they will be taxed according to their value.

The border gates where you enter the country have red and green lines. When entering Türkiye, if you do not have an item to declare to the customs, you should use the green line. If you have an item to declare to the customs or if you are not sure if you should make a declaration for your goods, you should use the red line.

Using either of the red or green lines does not mean that you can import goods that are forbidden to import into Türkiye or subject to a permit to be imported. When using either of the red or green lines, you can always be subject to inspection by customs officers.

If the products that you bring along to Türkiye exceed the exemption limits, they may subject to penalty.
